Fiscal Year 2020 Actual vs. Budget

Income

- Offertory is unfavorable due to the impact of COVID-19 beginning in March.
- Grand Annual favorable due to increased participation.
- Sacramentals & Easter Flower donations decreased due to COVID-19.
- CYO Basketball/Youth is unfavorable due to budgeted mission trips & fundraising did not occur but are offset in expenses.
- Gifts, Donations, Fundraising are unfavorable due to event cancellations, partially offset by Marital Trust gift \$20k.

Expense

- Staff Salaries & Benefits are favorable mostly due to reduced musician costs.
- Religious Education is favorable due to open position (Feb) and curtailment of program beginning in March due to COVID-19.
- Office & Administrative is favorable due to in-house production of Grand Annual/Offertory Pledge materials.
- Pastoral & Liturgical are favorable due to curtailment of pastoral activities due to COVID-19.
- CYO Basketball/Youth is favorable due to cancellation of budgeted mission trips but is offset in income.
- Capital improvements include replacement of 3 Church air conditioners \$15k.

Fiscal Year 2021 Budget vs. 2020 Actual

Income

- Offertory/Grand Annual/Religious Ed at reduced levels assuming COVID-19 impact will continue through FY '21.
- CYO Basketball/Youth assumed there would be a basketball season, but Youth activities will be limited due to COVID-19.
- Gifts, Donations, Fundraising are reduced to exclude the Marital Trust gift \$20k received in FY '20.

Expense

- Staff Salaries & Benefits decreased due to lower income partially offset by increased shared collaborative ratio from 67% to 71.9%.
- Clergy Stipends & Benefits are unfavorable due to increased shared clergy collaborative ratio from 50% to 71.9%.
- Religious Ed - Salaries decreased due to 2 unfilled positions partially offset by increased shared collaborative ratio from 67% to 71.9%.
- Facilities, Maintenance, Heat, and Utilities increased mostly due to Property Insurance.
- CYO Basketball/Youth assumed there would be a basketball season, but Youth activities will be limited due to COVID-19.
- Capital improvements include work on Church and rectory.

Cash Balances include \$57,200 received from the Federal Paycheck Protection Program in April 2020.
