## FISCAL YEAR 2008 FINANCIAL REPORT TO PARISHIONERS

## Dear Parishioners,

Here is the annual financial report for our parish. In this report, we have tried to explain in a simple and straight-forward manner the annual financial picture of our parish. To this end, we have broken-down our profit and loss statement into several distinct sections to help better explain where monies came from and where they were directed. The first section represents the true recurring income and expenses taken in and spent on a regular basis. It is from this regular income and based on our regular expenses that we have prepared our budget for this coming year.

The Non-Operating Income section contains aspects of our parish ministries that require us to keep separate accounts that reflect the specialized nature of these funds. Examples of this would include our Bingo program, Cevicos missionary outreach and the recent inclusion of our Brazilian outreach. Other sources of income and expenditures reflect one-time events or monies realized for specific projects.

As we have explained in previous financial reports, our capital improvement budget is separate from our operating budget. The bulk of those funds have come from the Archdiocese.
